Mill Creek Estates

- Kyle would like to subdivide some of the Mill Creek property into 3 lots for the purpose of building houses.
- SEQR was completed in the original application in 2003.
- Nancy is going ro review the previous application to make sure all they have all the variances.
- No driveway/road on the property from one end to the other.
- Kyle will be putting an access road from one end to the other and it will be gated.
- They are trimming and cutting trees because the are in the way of the tractors but aren't in the way of the subdivision.
- Eventually they will have to have a space for a recreation facility.
