Supervisor Mahus opened the Public Hearing on the Preliminary Town Budget for the year 2017. Supervisor Mahus requested comments from the board or from visitors in attendance. NO RESPONSE. Mahus stated that the tax rates should be reduced with the use of less fund balance. Board members went over the budget line by line. An error was found on the page #10 in Supt of Highways, Line A5010.1 (Budget This year as amended). The amount should read 63,400.00 not 61,557.00. This would change the Personal Services total to 68,400.00 and the Total Transportation for this line to 100,850.00.
